Explanation of ownership percentages:

Time Warner Cable Inc. ("TWC") is owned by Time Warner Inc. ("TW"), which owns, through wholly-owned subsidiaries, 84.04% of TWC's outstanding Class A Common Stock and 100% of its outstanding Class B Common Stock. The remaining 15.96% of TWC's Class A Common Stock is publicly traded. Time Warner NY Cable LLC ("TWNYS") is 100% owned by TW NY Cable Holding Inc., which is 87.55% owned by Time Warner Cable LLC and 12.45% owned, through wholly-owned subsidiaries, by TW. Time Warner Cable LLC is 100% owned by TWC. Time Warner Entertainment Company, L.P. ("TWE") is, through wholly-owned subsidiaries, 55.3% owned by TWNYC and, 44.7% owned by Time Warner Cable LLC. Time Warner Entertainment-Advance/Newhouse Partnership ("TWEAN") is 100% controlled by TWE.
